# The Challenge

Devoteam was striving for ZERO errors in the production stage, where the biggest challenge is user data in context. Users can generate the most creative errors in any platform which cannot be found in any data set no matter how well it was developed.

To overcome this challenge, the team needed production data for testing in all the non-production stages. This generated data created new obstacles such as GDPR compliance and data migration in a fast, on-demand system between the different development stages. # The Decision & Methodology

Devoteam has worked with and repeatedly recommended DMM as the solution to these kind of projects. In this case they required DMM to retrieve updated production data, anonymize it while maintaining its integrity and any potential user error, then migrate it to the other development stages for more accurate testing.

The usage of real user data is something that requires GDPR compliance as well as the possibility to maintain data integrity regardless of any user error.

There was also a need for all the processes to be completed ondemand to refresh the data with the most recent values.

# The **Results**

The end result could vary according to the number of tenants that were migrated at intervals of 2 hours per project and approximately 30 minutes per tenant.

Every migration encompassed approximately 1.4 GB of data to be anonymized and migrated.

With this methodology in place, the ZERO error goal in the production stage got a lot closer to becoming a reality. **The** errors were detected in earlier stages and corrected leading to a much better user experience.

DMM was paramount to perform the regular refreshes of the development test and acceptance stages that were required on the road to the ZERO production error goal by making it easier to migrate data to the other stages in the environment. In the mid-term, Devoteam/Outfit was also using DMM's data anonymization features to help comply with GDPR and information security rules and best practices.
